## Provide your pitch

Once you have refined your idea, write your presentation brief in an appealing way that provides a 'pitch' for why people should come to your session. Promote your product or service by being an expert, not a salesperson. Attendees are more likely to recognise professionalism and benefits of a product or service if they believe you are the best at what you do.

## Writing a Short Bio

As part of your application, you will be asked for a short biography (no longer than 100 words) so that we can learn more about you.

What to include:

- Your professional history, including key accomplishments
- Comparable experience presenting

## Presentation Brief (300 words)

The Presentation Brief is a summary of the content of your presentation. It should be written in an appealing way that provides a 'pitch' for why people should come to your session. Write your presentation brief as you wish it to appear in the conference booklet and write in third person.

What to include:

- the purpose of your presentation
- if your presentation will be suited for managers
- an outline of the argument made based on the key concepts of research and strata methods or both
- the main findings and/or conclusions
- the implications for strata practice
- the specific requirements noted in the description of your chosen session format.

You should keep in mind the criteria for assessment A to C in preparing your presentation brief.

Think about your audience. Your audience is diverse – across disciplines, uses and knowledge of strata – ensure your intention will be widely understood.





## Presentation Overview

Submit your presentation summary including key topics to be covered. Case studies or supporting documents to further support your presentation content.

Include in your presentation overview:

- presents the important concepts and facts to explain the proposal's contribution to the conference theme
- outlines the relevance of your presentation to strata and the importance of what you are proposing
- explains your contribution to the conference theme and sub themes

## Submit your proposal by 8 April

Prepare your proposal in a word file first. Answer these details:

- Proposed Presentation Title
- Primary Presenter
- Additional Presenters (for proposed panel style session)
- Presentation Brief (300 words)
- Presentation overview

## Criteria for assessment

In preparing your proposal's Presentation Brief please ensure you address the following criteria for assessment:

### Criteria A

Relevance/importance to SCA Audience: The proposal should address topics that are of importance to a broad audience within Strata and, if accepted, be likely to attract an audience.

### Criteria B

Technical quality: A proposal should meet high standards of technical quality in terms of methodological, conceptual and logical rigor.

### Criteria C

Contribution to strata methods, theories, policies and practices: Proposals presenting the results, findings, and circumstances of a specific subject matter are welcome but should also identify how it contributes to the broader issues of significance for advancement of the strata knowledge-base or to skill building.

**NOTE:** No individual may present in more than two conference sessions, including as a co-presenter.
